The Crescent City Jaycees are looking forward to sponsoring their 42nd Annual Eighth Grade Boys Invitational Basketball Tournament, set for March 5th & 6th, 2010.

This letter is informational and not an invitation to the tournament. The tournament will consist of 56 boys teams divided into "AAA", "AA", "A-1", "A-2", "B1", "B-2", and "C" divisions. We offer good competition for all and any size school. There will be an entry fee of \$65.00 for this year's tournament. There will be an additional \$20.00 sponsor fee. The sponsor fee will be used for our tournament scholarship fund.

If your school is selected to participate, we will ask you to provide a scorekeeper at the scorer/timers table. In some cases, your scorekeeper will be designated as the official scorekeeper for the game you are playing.

In conjunction with the basketball tournament, there will be a sportsmanship award, hoop shoot contest, cheerleading competition, a poster contest and a tournament Queen selected from those schools who wish to participate in these activities. Also, there will be a free luncheon on Saturday for all the tournament participants. A "Get Acquainted Party" for coaches, referees, administrators, and their spouses will be held Friday evening after the first round of games.
