## TOURNAMENT POSTER CONTEST RULES & GUIDELINES

1. Each school who wishes to participate may bring one poster to the tournament. Posters will be judged by local artists. Awards will be given to the 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place posters. Honorable mention may also be awarded to posters that the judges wish to recognize.
2. No more than four (4) students may work on any one poster. The names of the students who work on the poster must be submitted on the Official Poster Contest Entry Form. Posters with the Official Poster Contest Entry Form attached, are required to be turned in at the meeting of the cheer coaches and princess advisors as shown on the Schedule of Events. Schools that do not bring cheerleaders to the tournament but wish to enter a poster may submit their entry at the coaches meeting on Friday afternoon.
3. Any member of the school student body may work on the poster including, cheerleaders, queen contestants, and players.
4. Students who work on the posters, will be given individual awards for the 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, and honorable mention posters.
5. Posters should be on Rolled Butcher Paper and shall not exceed a width of 36" or a length of 72". This includes a border or any paste-on that extends beyond the edge of the paper. They should be large enough to view and read from across the gym floor.
6. The design and makeup of the poster must be entirely student work. The poster should emphasize the school name, team name, mascot, school colors, and basketball, but does not need to include all of the above.
7. Watercolor, poster paint, or crayon may be used. Cut-outs pasted on a background paper are also allowed.
8. Posters will be judged on the following:
  - a. Original Artwork
  - b. Original Ideas
  - c. Lettering
9. Posters and Entry Forms must be submitted for competition at either the cheer coach or basketball coaches meetings held on Friday afternoon.
10. The tournament committee will display all the posters submitted for the contest in the Del Norte High School Thunen Gym. Only posters that have been officially entered in the competition may be displayed in the Thunen Gym. Spirit posters and signs may be displayed in other gyms during your games. However, they must be removed as soon as the game is over and they will not be judged.
